RESIDENTIAL AND VISITOR PARKING PERMIT

No person shall be permitted to park any vehicle on any public street or portion thereof located in the following described zones of the City of Atlantic City, for more than three (3) hours unless:

1. The vehicle is owned or operated on a regular basis by a City resident.
2. The vehicle has a valid resident or special guest parking permit (hereinafter referred to as “Visitor” Permit) displayed on either the rear panel window, on the driver’s side or on the back window, on the driver’s side in such a manner to be readily examined by enforcement personnel.

Residential Parking Permit Zones

“A” Zone – Albany Avenue to Jackson Avenue from the Ocean to the inside thoroughfare.

“B” Zone – Missouri Avenue to Albany Avenue from the inside thoroughfare to the Boardwalk.

“C” Zone – Between Pennsylvania Avenue to Connecticut Avenue and Arctic Avenue (excluding Arctic Avenue) and Huron Avenue (excluding Huron Avenue).

Requirements

Each property is entitled to a visitor permit.

Each legal resident is entitled to one (1) sticker per vehicle registered in their name.

Proof of Residency

To receive a sticker you must have a valid vehicle registration.

Present two (2) of the follow type of identification for stickers or visitor passes are: **(Must be Current)**

- Utility Bill (telephone, cable, electric, gas) must have name and address
- Lease (if renter) **MUST BE NOTARIZED**
- Notarized statement from Landlord (if lease is not available)

Special Guest (“Visitor”) Permit

Visitor Permits are issued for the sole purpose of visiting a person or persons within the resident household to whom the Visitor Permit being displayed was issued. A Visitor Permit may be used by such persons for not more than three (3) consecutive days. Visitor Permits may be used only on streets located within two (2) city blocks of the household to whom said Visitor Permit has been issued.

Permits issued for Businesses

To apply for Business Parking Permits, you must submit the following information:

1. Mercantile License
2. Statement from Manager or letterhead stationery listing names of employees eligible for permits, including applicant.
3. List times and days of business operation.
4. Copies of each eligible employee’s vehicle registration.
5. Maximum of ten (10) permits.
